## Event Overview

The [Next Steps on the NHS Five Year Forward View](#) (5YFV) report issued a few months ago, makes several requests of Estates, Infrastructure, Capital, and Clinical Support Services, including the need to achieve over £100 million in savings in 2017/18 and to dispose of £2bn of surplus assets. The Naylor Report also made several recommendations to encourage and incentivise Trusts to support transformation in the NHS, including the requirement for Trusts to develop affordable estates and infrastructure plans, with an associated capital strategy, to deliver the 5YFV and address the issue of backlog maintenance.
